

Application for Type 2 Secondary Level Courses for Post-secondary Course Credit

For Type 2 application, completion of Secondary Level Courses would be recognized for Post-secondary Course Credits for dual credit recognition. The Ministry would encourage application by the other entity, primarily as a mechanism of tracking the utilization of the dual credit recognition program. However, because the student would be studying an approved secondary level course, the Ministry would issue the credit, and another entity would be able to offer credit to the student without Ministry approval.

This dual credit recognition can occur when a student takes a Saskatchewan secondary level course for which the post-secondary institution will give credit under certain conditions.
