Things to Note: Should we receive an abundance of applications, priority will be given to students currently enrolled in grade 12 with the remaining applicants to be placed on a waiting list. Students are accepted based on the availability of a work placement. Lastly, students are only able to take the course starting in Sept. each year (which is one course per year) as the course runs from Sept. to April each year.
